Education Merit Award 2017 – Criteria and Guidelines

1. The person making the nomination must be a member of SDBBS.
2. The nominee should either be a member or from the member’s immediate family. The member must also have been a SDBBS member at the time of nominee writing the respective examination.
3. The nominee should meet the minimum degree of excellence listed below for each award category:

| No. | Examination | Nomination Criteria |
|-----|--|---|
| 1. | Primary School Leaving Exam (PSLE) | 4A*s with T score of 265 & above (or) T score of 270 & above |
| 2. | GCE ‘O’ Level Exam | ‘A1’s in the 8 subjects (English, Combined Humanities, Maths, Addl Maths, Physics, Chemistry, Biology, Higher Tamil) |
| 3. | Year 4 of Integrated Program | Top 5% of the school’s cohort in the Year 4 examination. Parents to submit a letter from the school stating the level of achievement. |
| 4. | GCE ‘A’ Level Exam | a) “A”s in Three H2 subjects + “A” in one H1 subject (or) “A”s in Four H2 subjects |
| 5. | NUS High School Diploma | CAP of 4.5 and above |
| 6. | IB Diploma | a) Minimum 43 Points b) “A” in Theory of Knowledge |
| 7. | CBSE / ICSE | Overall average of 95% in the 12 th year exams |
| 8. | Polytechnic Graduation Exam | a) A Diploma with Merit b) GPA of 3.6 and above |
| 9. | NUS / NTU / SMU Graduation Exam | At least a Second Class (Upper Division) Honors Degree. |
| 10. | Graduation exam of other institutions (local / overseas) | Exceptionally outstanding performance in such examinations will be considered separately on a case-by-case basis. |

4. The grades/scores that have been indicated above are only the **minimum for nomination** and not for selection of the award. Selection will depend upon further variable factors.
5. The decision of the Management Committee shall be final and no reasons need to be given for non-selection.
6. The nomination form along with copies of the supporting documents should be submitted to SDBBS Secretariat at the address mentioned on the top of the form **on or before 31 July 2017**. Late submissions will strictly not be accepted.
